Heritage Saskatchewan MEMBERSHIP CATEGORIES

Individual: Open to any Saskatchewan resident who supports the goals, values and objectives of Heritage Saskatchewan. **Fee = \$25**

Associate: Open to any for-profit enterprise, organization, government agency or ministry/ department which shares the goals and purposes of Heritage Saskatchewan. **Fee = \$250**

Non-Profit Associations & Institutions: Open to any incorporated non-profit organization, or any institution whose primary mandate is the stewardship, preservation, research, education and engagement of heritage, and/or any member-driven organization that represents the interests of heritage and heritage practitioners.

This includes any of the following groups, with heritage as their primary objective:

- non-profit organizations or co-operatives
- unions & professional associations
- boards, agencies or municipal heritage committees, that are legislated or are arms-length from government.
